The Chinese government is investing to expand insurance coverage and improve care, but the country's healthcare provision remains inadequate. For major U.S. companies that market drugs, medical devices, and healthcare services, China represents an important opportunity. Market access barriers, though, are tilting the playing field against U.S. companies – a losing proposition for both the U.S. economy and Chinese patients.
